- ∇ The financial support under the sliding scale tuition formula is made possible through non-parent donors, members of the school association, volunteers, and fundraisers such as the annual Redeemer dinner auction and grocery coupon sales.
- ∇ You are encouraged to support these initiatives so Christian education continues to be available to families at different economic levels.
- ∇ Tuition is based on family income and \$500 for each additional student per family.
- ∇ Families with children enrolled concurrently in a Christian elementary school that has a discount agreement with Redeemer, are entitled to a discount of up to 25%.

After-tax Cost of Education

Canada Revenue Agency considers religious education to be a charitable activity, Redeemer, as a registered charity, is permitted to issue a charitable receipt for the portion that **a Umbe** over and above the *cost of education*. The *cost of education* is the cost of providing the non-religious portion of **YUW** student's education. This number is determined annually, following CRA rules and regulations."
